

**NOTICE OF PUBLIC HEARING
TOWN OF KENLY
FY 19 COMMUNITY DEVELOPMENT BLOCK GRANT INFRASTRUCTURE (CDBG-I) PROGRAM**

Notice is hereby given that the Town Council of the Town of Kenly will hold a public hearing on **Monday, March 13, 2023, at 7:00 PM**, or as soon thereafter as the agenda will allow, at Town Hall, Council Chambers, 207 W. Second Street, Kenly, NC 27542. Please visit the Town's website for more info at www.townofkenly.com. All Town Hall visitors are to comply with applicable federal, state, and local coronavirus guidelines.

The purpose of the public hearing is to update the scope of the project area for the FY19 CDBG-I Sewer Rehabilitation / Replacement Project and allow residents an opportunity to express their views. The total project budget remains unchanged at \$1,998,672 in CDBG-I funds (100% of total project costs) from NC Department of Environmental Quality (DEQ) Division of Water Infrastructure (DWI).

This project includes closed circuit television (CCTV) inspection and rehabilitation/replacement of aging/deteriorated gravity sewer line with associated manholes, point repairs, service reconnections, and appurtenances. This project will improve local public and environmental health by and reducing the possibility of sanitary sewer overflows. Project activities will take place primarily in low- and moderate-income (LMI) residential areas with the worst sewer line conditions. The project area has a population that is at least 51% LMI, and therefore, 100% of the CDBG funds will be used to benefit LMI persons.

Persons having any questions concerning the CDBG-I Program are urged to attend the public hearing, make their views known, and submit comments. A public information file exists at Town Hall and may be viewed upon request.
