Two ways to address text amendment: Rezone Property (B3) allowed by right. Changing B2/B3; current zoning ordinances don't allow. Cease operations for 180 won't be allowed to continue operation.

#### 2. Special Use Permit -300 S College Avenue – Quasi-Judicial

A quasi-judicial hearing resembles a court trial where testimony is presented. Citizens may give testimony in a quasi-judicial hearing after they have taken an oath. Town Council acts like a court of law and receives only sworn testimony and other credible evidence. In addition, the Town Council must make findings of fact based upon the evidence presented. The Town Council refrains from "ex parte communication" about these cases, as the Town Council must decide based solely on the evidence presented at the hearing itself.

Monica Chevalier: WitherRavenel project manager; presented information concerning the CDBG Grant. The slip lining project on Sixth and Seventh street partially completed but postponed to ask for an extension. Reduction in scope due to time limitations. Intent moving forward. 1.9 million CDBG, NC-DENR; Public Hearing; Citizen Participation; Favorable bid process, prices for materials may increase as well as the price for labor. Funds are temporarily frozen until the 2022 audit is completed. There is a 6 month change order period. The Town of Kenly doesn't have enough capital to subsidize. There have been multiple auditors and staff transitions. The state doesn't give extensions for late audits. Paperwork for extension hasn't been submitted but needs to be completed by 03/31/2023. DWI encouraged Town of Kenly to submit extension.
