## b. State Grants

Presenter: Tony Sears: Interim Town Manager

Manger Sears informed the Council that the Town of Kenly was awarded three grants during the last session of the General Assembly.

- a. Town of Kenly Stormwater Improvements DPS \$200,00
- b. Town of Kenly Water Infrastructure Fund DEQ \$860,275
- c. Town of Kenly Economic Development OSMB \$312,158

Stormwater Improvement – is a \$200,000 grant. Manager Sears has been in contact with WithersRavenel regarding putting in a GoldenLeaf application. Manager Sears wanted to try and find a way to maximize the monies to get a greater benefit.

Water Infrastructure Fund – will be used for not only water but sewer. Manager stated that he and PW Director Pitts had met with representative from WithersRavenel to assist with grant. Initial thoughts would be to complete the USDA project that is ongoing on six, seventh, and Lincoln St.

Economic Development – Manager Sears looked into what these monies could be used for. It appears to him after talking with representatives from the State that it is a loose interpretation and the state provided examples of allowable expenditures. Discussion between the Manager and the Council involved demolition of the old civic center and construction of pickle ball courts. If funds were still available maybe the consideration of a shelter to house something like a farmer's market.

**Police department:** Requires more resources for uniforms, salaries and maintenance for equipment and vehicles.

**Library:** Increase salaries for staff and updated software and more space for books and conference rooms and more computers for residents.

**Parks and Recreation:** Increase salary for staff and allot Director position to Full Time. More playground equipment and more staff positions created for parks. Upgrade Sports Equipment and software and computer equipment and replace trailer if possible.

**Wastewater Treatment Plant**: Increase budget for extra help when necessary or training for current employees. Better software and computer/telephone system.
