1. CLOSEOUT PUBLIC HEARING FOR CDBG-I PROGRAM Review and Assess the performance of the Town's FY19 CDBG-I Sewer Rehabilitation Replacement Project *Presenter: Tony Sears, Interim Town Manager*

The purpose of the public hearing is to discuss program accomplishments and performance for the project and allow residents an opportunity to express their views for the FY19 Community Development Block Grant for the Infrastructure Project, CDBG-I Grant # 19-I-3109. In April 2020, the Town of Kenly received a U.S. Department of Housing and Urban Development (HUD) CDBG-I grant from the North Carolina Department of Environmental Quality (DEQ) Division of Water Infrastructure (DWI). With the \$1,998,672 funds awarded, this project included closed circuit television (CCTV) inspection and rehabilitation/replacement of aged (over 50 years) deteriorated gravity sewer line along with associated manholes, point repairs, service reconnections, and related appurtenances. This project improved local public and environmental health by eliminating inflow and infiltration and reducing the possibility of sanitary sewer overflows that flow into local tributaries and surface waters. The sewer lines were like-for-like replacement via dig and replace, or rehabilitated with trenchless methods. All work took place within the existing utility easements, within previously disturbed rights-of-way, outside of known floodways, and within residential areas of Town. No new proposed sewer connections occurred. The total CDBG-I grant is \$1,998,672.00 (100.00% of the project costs). Eligible CDBG-I activities were maximized with this project. CDBG funds remain frozen due to submitting fiscal audits late. The town could not secure temporary gap temporary funding from the Local Government Commission. Instead, the town temporarily committed local funds with time-limited expenditure authorization being prior to March 31, 2023. The contractor was limited to a 5-week time period to construct a portion of the project due to CDBG restrictions and requirements. Because not all sewer funds were used, administrative funds also need to be DE obligated. A total of \$1,068,549.20 unexpended funds is being DE obligated.
